RESOLUTION APPROVING THE 2025-26 COUNTY BAIL SCHEDULE

WHEREAS, the Board of Supervisors of the County of Santa Cruz determines the fines for violating various provisions of the County Code and traffic-related programs that operate on designated through highways, private roads, and County Parks; and

WHEREAS, the County Bail Schedule is used by the Superior Court of California, County of Santa Cruz, to verify fine amounts for violations of the County Code and County traffic-related programs; and

WHEREAS, this schedule does not preclude County Counsel, Code Compliance Administrative Hearing Officers, or Code Compliance Investigators from setting and recovering administrative or civil penalties to address abatement of violations of the County's land use codes; similarly, it does not supersede penalties collected directly through the Santa Cruz County Animal Services Authority's administrative citation program; and

WHEREAS, at the request of the Superior Court, staff has conducted a review of the current Bail Schedule, has determined that it requires updates and recommends the Board of Supervisors approve the updated Court Bail Schedule for 2025-26.

NOW, THEREFORE, the Board of Supervisors of the County of Santa Cruz resolves and orders that the County of Santa Cruz 2025-26 Bail Schedule, attached hereto as Exhibit 1, is hereby approved.

BE IT FURTHER RESOLVED AND ORDERED that this Resolution takes precedence over any previously adopted resolutions relating to the County's Bail Schedule.
