General Information

Penal Code section 1269b(c) states that it is the duty of the superior court judges in each county to prepare, adopt, and annually revise a uniform countywide schedule of bail for all bailable felony offenses and for all misdemeanor and infraction offenses except Vehicle Code infractions. The penalty schedule for infraction violations of the Vehicle Code shall be established by the Judicial Council in accordance with Section 40310 of the Vehicle Code.

This schedule contains a list of the offenses and the amounts of bail applicable for each as the judges determine to be appropriate. It contains a general clause for designated amounts of base bail for offenses not specifically listed in the schedule. (See Felony Bail Schedule, Page 5.) A copy of this schedule has been sent to the officer in charge of the county jail and to the Judicial Council. (See Penal Code section 1269b(f)(1).)

If a defendant or arrested person so released fails to appear at the time and in the court so ordered upon their release from custody, Sections 1305 and 1306 apply. (See Penal Code section 1269b(h))

After a defendant's first appearance in court, the amount of bail will lie within the sound discretion of the judicial officer before whom the defendant appeared and may be greater or less than the amount set forth in this schedule, subject to the provisions of Penal Code section 1275. This schedule may also be used by a magistrate in fixing bail pursuant to Penal Code section 815a at the time an arrest warrant is issued, the amount of which lies in the sound discretion of the magistrate.

Prevailing legislation places the burden on law enforcement agencies to notify the magistrate if the scheduled bail is not adequate for the crime. Penal Code section 1269c provides that if a defendant is arrested without a warrant for a bailable felony offense or for a misdemeanor violation of a domestic violence restraining order, and a peace officer has reasonable cause to believe that the amount of bail set forth in the schedule is insufficient to assure the defendant's appearance or to assure the protection of a victim, or a family member of a victim, the police officer shall prepare a declaration and file it with the magistrate requesting higher bail. A police officer may make this declaration orally to the magistrate. (See Penal Code section 1270.1(e).)

Felony Bail Schedule

This section of the bail schedule pertains to felony violations of the California Penal Code, California Health and Safety Code, California Vehicle Code, and the California Business and Professions Code. The base bail for felony violations not contained in this schedule shall be in the amount of \$5,000.00 with mandatory court appearance.

All felony violations shall be processed by the Criminal Division of the Superior Court. All felony violations require mandatory court appearance. When a defendant is booked for more than one violation resulting from the same factual situation, bail must be based on the violation showing the highest bail amount. Bail WILL NOT be accumulated for all violations of the same factual situation. On any attempted charge preceded by 664/, bail should be set at one-half the bail set for the original charge.

INSTRUCTION FOR SETTING FELONY BAIL:

1. Select the most serious offense from among multiple charges.

2. Check to see if there are any enhancements listed among the charges (e.g., PC 12022.5).

3. If there is an enhancement, add the amount from the bail enhancement schedule to the bail for the most serious felony offense. See specific instructions under "Bail Enhancements," starting on Page 18 of this schedule.

4. If there are no enhancements, bail shall be set per the schedule for the most serious offense.

5. For PC 182 offenses, set bail at the amount listed for the crime that is the object of conspiracy.

Requests to increase a bail amount contained in this schedule must be presented to a judge for prior authorization. All requests for increased bail over the scheduled amount must be accompanied by a *Request for Setting Bail* (Form PTS 253) from the requesting agency.
