# Family Preservation Court (FPC) Benefits and Key Highlights

- **Voluntary Participation:** FPC is a voluntary program for families with substance use disorders with an open dependency case and Non-Minor Dependents in Child Welfare.
- **Focus on reunification:** The program aims to preserve and reunify families by addressing the root causes of court involvement.
- **Enhanced Access to Services:** Participants gain increased access to a range of treatment and services, including support for substance use, mental health, parent-child Relationships, and trauma.
- **Accountability and support:** The program promotes accountability through supervised services and treatment, supporting participants in achieving reunification and long-term stability while enhancing public safety.
- **Collaborative Team Approach:**

FPC operates with a strength-based team including:

- You
- Commissioner Gregory Peinado
- County Substance Use Disorder Staff
- Child Welfare Staff
- Treatment providers and community partners such as Sobriety Works, Janus, Parents Center, parent mentors and Leaps and Bounds.

## The Purpose Behind Family Preservation Court

For more than 10 years, FPC has successfully addressed dependency cases involving substance use and behavioral health issues of families involved with Child Welfare.

### Program Phases

The Family Preservation Court program is structured in three phases, where the intensity of treatment services, alcohol, and drug testing, and court appearances gradually decrease as participants advance. The duration of each phase varies on the completion of individual goals.

### Program Phase System: Program Phases:

#### **Phase 1 (1<sup>st</sup> and 3<sup>rd</sup> Wednesday of every month):**

Identify your treatment needs, review your FCS case plan, and begin the Leaps and Bounds program if your child is under 5 years old.

#### **Phase 2 (Monthly Attendance):**

Engage in intensive treatment services.

#### **Phase 3 (Every 6 Weeks):**

Transition to continuing care as you advance through the program.
