Step 2: If called to serve, report to the Jury Assembly Room (behind the Courthouse) 701 Ocean Street, Santa Cruz, CA 95060 at the date and time provided.

Step 3: To request a postponement, excuse, or disqualification, scan the QR code below, visit www.santacruzcourt.org or call 831-480-8005. To speak to a live person call 831-420-2203, Mon-Fri 8:00 AM-1:00 PM.
