Resolving your ticket is easy. Take action now to resolve it. You may be able to choose one of the following options:

- Pay your fine
- Schedule a court date to contest your citation
- Clear a correctable violation and proof of insurance (reduced fees apply)
- Traffic school
- Request a Trial by Written Declaration (for moving violations only)
- Request community service or payment plan

#### **Financial Hardship**

You may request to perform community service, set up a payment plan, or receive a fine reduction in order to address your citation. Visit our Website at [www.santacruzcourt.org/divisions/traffic](http://www.santacruzcourt.org/divisions/traffic) to learn more about each of these options and to get answers to frequently asked questions. Access to other resources such as a list of approved traffic school programs is also available online.

#### **Traffic Violator School ("TVS")**

TVS requires that you pay the full bail amount together with a non-refunded \$52 fee. (Traffic schools charge a separate fee.) If you are eligible and do not attend TVS, auto insurance may be adversely affected. With TVS, One conviction in any 18-month period will be held confidential and is not shown on a driving record. Please read all instructions for TVS on our Traffic Webpage (see Frequently Asked Question #7). **Correctable violations must be corrected before electing TVS.**

#### **Trial By Written Declaration ("TBD")**

Individuals wishing to contest a citation without coming to court may request a TBD for moving violations only. The required TBD forms, including a Waiver of Arraignment, are located on the Traffic Section of the court's website. TBD requests must be made by the due date on Page 1 of this notice. Full payment of fine must be included with the TBD forms. Make check or money order payable to *Superior Court of Santa Cruz County*. No extensions of time are allowed with TBD requests.

#### **Correctable Violations ("CV")**

Violations qualifying as correctable will be noted on the citation. **These violations must be corrected before electing traffic school and a \$25 fee for each correctable violation must be paid in place of the fine amount.** Some CV's may be corrected and signed off by a law enforcement officer ("CLEA"). Driver's license and registration violations may be corrected by DMV or CLEA. Signed citations, as well as payment for the violation, may be delivered to either court location on Page 1 or by mail to the Ocean Street address only. Please note that violations of Vehicle Code 27156(b) violations require a court appearance to show correction and cannot be paid online. Please contact the court for a court date.

#### **Proof of Insurance ("PI")**

Insurance valid on the date of a citation may be presented to the court to reduce a fine. Insurance purchased after the violation date must be presented in court with a plea of guilty or no contest for a possible reduction. Law Enforcement Agencies cannot sign off on these violations. Proof of insurance must be presented in person or by mail to either the Santa Cruz or Watsonville courthouse.
