



Felony Bail Schedule - Bail Enhancements

BAIL ENHANCEMENTS:

If any of the following allegations are contained among the booking charges, the corresponding bail or bails shall be added to the underlying charge. For example:

1. H&S 11351 with an allegation of PC 1203.07 (large quantity or prior conviction), the bail will be \$10,000 for the H&S 11351 allegation plus \$50,000 for the PC 1203.07 enhancement for a total of \$60,000.
2. PC 245 with a special allegation of PC 12022.7 will be \$10,000 for the PC 245 allegation plus \$50,000 for the PC 12022.7 enhancement for a total of \$60,000.
